

19 goals in one action, YOU DECIDE the score!

19 National charities are collecting donations together in Son en Breugel from April 7th to April 20th 2025.

Dear residents of Son en Breugel,

From April 7th to April 20th 2025, 19 national charitable organizations will be collecting donations in our municipality. **Like you now know, only 1 collector will come to the door on behalf of the 19 charities.** You can choose which organization(s) you want to give to. All participating organizations have the CBF certification (Central Bureau Fundraising). CBF assesses whether charitable organizations meet strict quality standards. The Stichting Goede Doelen Week Son en Breugel is included in the Stichting Donateursbelangen (Donors Interest Foundation): www.donateursbelangen.nl/goede-doelen-weken.

Your contribution will initially go to the bank account of the Stichting Goede Doelen Week Son en Breugel. After the collection week, the foundation will ensure that the promised amounts are transferred to the charities, in accordance with the received forms. The organization of the Goede Doelen Week Son en Breugel is run by volunteers. Organizational costs (printing, collection materials, etc.) are covered by sponsorship and by retaining a small percentage of the proceeds.

The Stichting Goede Doelen Week Son en Breugel (Foundation Good Causes Week Son en Breugel) has an ANBI status. This means that donors can deduct their gifts from their income tax or corporate taxes.

Some companies in the region, such as ASML, offer donation matching. Donation matching is a policy where employers match their employees' donations to a nonprofit organization. Does your company use Bright Funds as a donation matching platform? From now on you can donate to the Goede Doelen Week Son en Breugel Foundation via **Bright Funds**. If you have any questions or need support when using Bright Funds, please contact your company contact person or the Bright Funds helpdesk. How to participate?

With this letter you will receive a form and a return envelope. On the form you can find the 19 national organizations that participate in the Goede Doelen Week Son en Breugel.

- You can look at the form to decide which organization(s) you want to give to.
- Fill in the amounts on the form and add them together.
- You can also only fill in a total amount and let that be divided among all organizations.

- This total amount is a donation to the Stichting Goede Doelen Week Son en Breugel.

This can be done in 3 different ways:

1. Transfer it yourself, possibly via the Goede Doelen Week Son en Breugel iDeal QR code.
 2. With cash.
 3. Via a one-time authorization.
- Put the form in the return envelope (with cash if you choose this option).
 - You can return the return envelope in 2 ways:
 1. From the collector: He/she has delivered the envelope to you and will collect it from you, whether or not according to an appointment made, between April 7th and 20th.
 2. There may not have been a collector available for your street or apartment complex or you may have missed the collector. We would then kindly ask you to put the envelope in the large collection box at one of the collection points below. Thank you very much for making the effort! From April 7th to 20th, large collection boxes will be available in Son en Breugel at:

 - COOP
 - Jumbo
 - PLUS
 - Het Dommelhuis
